Admission Process for International Students

A family interview will be scheduled after the school receives the following documents:

1. International Student Application Form ... (found on our website)
2. International Pastor's Questionnaire (found on our website)
3. Student Home-Stay Information sheet (found on our website)
4. SLEP or TOEFL test scores (or other verification of English language proficiency)
5. A copy of a report card from this current school year.

After the interview and upon acceptance, these documents will be sent to the student (or are found on our website), and should be filled out and returned to Calvin Christian:

6. Student Participation Agreement(on our website, please return to Calvin Christian)
7. Medical Insurance Form & options ... (on website, please return the form to Calvin Christian)
8. Travel Arrangement Form (on our website, please return to Calvin Christian)
9. Temporary Custodianship Form (please return to Calvin Christian)
10. Junior High Electives sheet ... (*only for junior high school students*) (please return to Calvin Christian)
11. High School Course Selection sheet .. (*only for high school students*) (please return to Calvin Christian)

After the interview and upon acceptance, these documents will be sent to the student:

12. Tuition & Fees Bill (Home-stay placement is on this)
13. Money Wire Transfer Information sheet
14. I-20 government document for attaining student visa
15. Guide to Immunizations Required for California School Entry

Enrollment will be finalized when the following, *in addition to those listed above*, are received by the school:

16. A Transcript of academic work for the last two or three years (with English translation)
17. Copy of Passport Information page (this can be brought with the student)
18. Immunization Records (this can be brought with the student)
19. The full amount of the tuition and fees ... (due by August 15)

Additional Notes

1. The I-20 form must be taken to the U.S. Embassy in the student's country to apply for an F-1 visa. This stage of the process can take over 30 days to apply for and receive the visa so application plans must be timed to insure that the student can arrive at least 5-10 days before the first day of school.
2. Tuition and fees can be paid by bank-transfer, money order, or certified check. Please make checks or money orders payable in U.S. dollars to: Calvin Christian School

Refund Policy

1. If the student is denied a visa, then a refund of tuition and fees, minus a \$200 administrative fee, is given. A copy of the original rejection letter from the Embassy must be submitted.
2. If the student withdraws prior to the first day of school, 2/3 of the tuition and fees is refundable.
3. If the student withdraws after the first day of school and within one month of admittance, 1/2 of the tuition and fees is refundable.
4. If the student withdraws after one month of attendance, there is no refund of tuition and fees, however, the home-stay fees will be refunded per academic quarter. If a student is enrolled for any part of a school quarter (first quarter, second quarter, third quarter, fourth quarter) then home-stay costs for that quarter are not refundable.
